A MESSAGE FROM OUR EXECUTIVE DIRECTOR

2022-2023 Year in Review

This past year has been one with many surprising and momentous opportunities and milestones. With plans to open a second PAL Center in Broome County by the end of 2022, we began the search for a new location in July and in September found a great location to lease. Then an amazing opportunity was made available to us: in seeking Broome County support for the initial year operational costs of the new PAL Center, Broome County Executive Jason Garnar suggested APRA funds could be more easily approved for a capital purchase. This was an absolute godsend for our agency as our current facility was in rapid deterioration and in October, we began to negotiate for a location that could house not only the new PAL Center but could also accommodate our entire agency and allow for future growth. In January '23, we signed an agreement

to purchase 338 & 346 Grand Avenue in Johnson City and we closed on the property on May 26, 2023! All of us at M&B are incredibly grateful for the support of Broome County, the Town of Union and the Decker Foundation for their support to help with the purchase of the property. We continued to benefit from other support for the property renovations: first through a partnership with the Village of Johnson City, we are receiving a Restore NY grant to help with immediate renovations and a children's outdoor playground (to be built Spring 2024); and grants from Broome United Way and the Community Foundation for SCNY to help with our move and major renovations. As we closed out the 6/30/23 year end; renovations are rapidly underway and our target move-in date is 7/28/23. The other major milestone our agency is planning for is my retirement! I have been so honored to have been Mothers & Babies founding Executive Director for the last 28 years and with the organization for almost 31 years - starting at first as the Coordinator for Healthy Mothers, Healthy Babies Coalition of SCNY in 1993 and incorporating M&BPN in July 1995. Starting with a NYS Dept of Health grant of \$125,000 in 1995, our growth has been incredible – growing from working by myself to now having an annual budget of over \$2.4 million and an amazingly talented and dedicated staff of 28 employees. I have also been honored and humbled by the commitment of our super volunteers those who have served as officers and members of our Board of Directors over the past many years. I am scared and not yet sure if I am excited about retirement I can't imagine life without Mothers & Babies. This agency has provided me personally so many opportunities which have enabled me to accept federal and state appointments which have allowed me to be part of advocating for improvements in maternal and infant health care and systems here in NYS and in some ways, across the country, but most importantly, here in our south central region. As I prepare to officially leave my position on September 30, 2023, the Board has undertaken a search for the next Director; we are packing and preparing for our move, the opening of the new center, finalizing a new location for the Binghamton PAL Center, and continuing to serve the individuals and families who seek our services, and partner with the many organizations which also work tirelessly to serve individuals and families in need. Mothers & Babies will always be in my heart. As I plan for my next life chapter; I am very proud of the foundation upon which M&B is built, the accomplishments of our agency, and am ready to let my "3 rd child" who is now an adult move forward independent of me. Finally, my sincerest thank you to all of our funders and donors for the investments you have made in Mothers & Babies – you have helped to ensure our future!

PERINATAL SERVICES

Our Perinatal Services provide crucial support to women, children and families who need us.
Our Community Health Workers

work with women of reproductive age to educate and connect them to the care and services they need to ensure the health and wellness for them and their families.

Women were helped by a Community Health Worker this year. Our Community Health Workers serve women of reproductive age who are in need of a connection to services. These services include but are not limited to: medical care, prenatal services, postpartum care, early intervention services, pediatric care, behavioral health services.

services, pediatric care, behavioral health services, various social services, mental health services, home visiting and education services. The CHWs provide visits in the hospital and at home to provide emotional support and education.

Pack n' Plays were distributed to families without a safe sleep space for their infant. Community Health Workers provide Safe Sleep education, as well as, training on how to properly set up the pack n' play.

New parents were educated on Safe Sleep practices for their infants. This education discusses the importance of putting a baby to sleep alone, on their backs, and in a crib free of toys, blankets and bumpers. Each new family received a sleep sack, brochures and information about tummy time, room sharing, and risk-reduction strategies.

Personal Health
Questionnaires (PHQ-9) were
administered by the
Community Health Workers to determine if followup mental health service referrals were needed.
These assessments are important in addressing
anxiety and depression including postpartum
depression which is described as depression suffered
by a mother following childbirth, typically due to the
combination of hormonal changes, psychological
adjustment to motherhood, and fatigue. Of the 417
questionnaires completed, 50 referrals were made.



Affordable healthcare is something that all people deserve in order to protect them from health and financial risk. Our NYS-certified Navigators provide free help and guide people through the process of enrolling in a health insurance plan from start to finish. Every day, with the assistance of a Navigator, many individuals, families, and small businesses are able to find affordable, high-quality plans with free preventive care and options for no/low premiums and no/low out-of-pocket costs. We are especially proud of our bilingual staff who can assist individuals in Spanish, Mandarin, Vietnamese, Creole, and French.

Our Community Health Advocate (CHA) assists people with getting the most out of their coverage, resolves medical billing, disputes coverage denials, and applies for hospital and prescription assistance programs.

Adults and children, including 166 5 1 86 pregnant women, were assisted in getting health insurance through the NYS Marketplace.

586 Clients were helped through our Community Health Advocate Program.

\$382,517

Total amount our clients saved with the help of our Community Health Advocate.





The PAL Center provides a safe, welcoming environment for over 300 families and caregivers each year. Families have opportunities to socialize, participate in activities, attend parenting classes, utilize on-site resources including a children's clothing closet, and connect to local resources within the community.

Supervised Visitation

This year the PAL Center hosted 814 individual supervised visits for 79 parents and 94 children. During visitation, PAL staff encourage positive interactions and help support the parent in their success.

Clothing and Diaper Distribution

The PAL Center houses a clothing closet that families in need can access once a month. Over the last year, 148 families visited the clothing closet for 375 children. The PAL Center also provides emergency diapers for families on a monthly basis. During the past year, 289 diaper requests were submitted and fulfilled. We would like to thank all of the community agencies, agency partners, and individuals who donated clothing, diapers, children's toys, and baby items. We would not be able to provide the community with so many resources without your continued support.

YOUTH SERVICES

Our programs are all-inclusive and provide a full range of information and skills which include abstinence and comprehensive sexual health education; methods to reduce risky behaviors, prevent pregnancy, STD's and HIV. Our life skills programs focus on healthy relationships, financial literacy, adolescent development and career success to help teens develop to their full potential.

We partnered with Rural Health Service Corps and hosted two AmeriCorps members who served as Youth **Education Specialists** and facilitated programs in schools, community agencies, and the Broome County Jail. They also worked on content to share on Facebook and Instagram. Youth Services social media pages have seen an increase of 65% in the number of followers.

Educators held 231 classroom programs for middle and high school youth in Broome, Tioga, and Otsego counties. Within those counties, programs were held at 18 different locations. Various locations included: Binghamton School District, Binghamton University, Candor School District, Catholic Charities of Broome County, Chenango Forks School District, Chenango Valley School District, Children's Home of Wyoming Conference, Harpursville School District, Johnson City School District, Milford School District, Newark Valley School District, Spencer Van-Etten School District, Susquehanna Valley School District, Union Endicott School District, and Windsor School District.



This year, the Youth Services Department subcontracted \$40,000 to six agencies to run summer programming focusing on life skills. They collectively reached 444 youth aged 10-19. The programs focused on mindfulness, community engagement, cultural awareness, STEAM, adulthood, independent living, self-sufficiency, higher education, job training, work experience, leadership skills, social-emotional support, arts and crafts, and relationship building.

The Youth Services Department also began offering programs to the inmates at the Broome County Jail in June 2023. Educators meet with male and female inmates weekly to discuss anger management, conflict resolution, mental health, healthy relationships, and domestic violence.
